Q4 Texas Congressman Gene Green is considering a proposal that would block the EPA from limiting carbon dioxide pollution. Some, like the National Association of Manufacturers, say Congress should block the EPA because "EPA's overregulation threatens manufacturers, businesses and jobs throughout America. Its actions will increase manufacturers' energy costs and make it more difficult to compete." Others, like the American Lung Association, say Congress should not block the EPA because doing so "would strip away Clean Air Act protections that safeguard Americans and their families from air pollution that puts their lives at risk."
